



BBQ Vendor Application

- Ribs Rods & Rock 'n Roll Inc. is the exclusive producer for the Ribs Rods & Rock 'n Roll – South Dakota BBQ Championship event and has the right to set policies for all activities associated with the event.
- Vendor application deadline is July 1, 2017. All vending applications will be reviewed and the initial invitations will be extended by the end of July. Other vending opportunities will be reviewed after Wednesday August 2 if any invitations are not accepted by that date.
- All items sold by the vendor at the event must be prepared at the event.
- Vendors must have a South Dakota sales tax ID, a South Dakota Health Department temporary permit and a certificate of liability. All paperwork must be returned by August 2, 2017.
- SD sales tax ID paperwork will be given to you at registration on Sept 8th. SD Department of Health Temporary Permit application can be found at <http://www.doh.sd.gov/PDF/tempfood.pdf>
- Vendors are not allowed to sell refreshments (water, soda etc) without approval.
- Minimum vending hours - Friday, Sept 8th 5:00pm-10:00pm and Saturday Sept 9th 11:00am-10:00pm. Set up times starts Friday at 10:00am. There is live music both nights so vendors may stay open until midnight.
- This agreement and the temporary permits must be returned prior to the event or vending cannot be allowed.
- BBQ vendors are not required to compete in the KCBS BBQ Competition. But if you wish to compete, the fee will be reduced and included in vending fee - \$350/\$450 to enter KCBS BBQ Competition.
